Re: Executive planning process and legislative update

Please find attached a copy of the State Library's pages from the Governor's budget book. (The entire Governor's recommended budget can be found at:

http://mt.gov/budget/budgets/2009_budget/2009_budget.asp.) As a summary, of the State Library's budget changes, I have provided the following brief table:

Legislation – both of our pieces of legislation are pending from Governor's office but approved to move forward from the Interim Education and Local Government Subcommittee. Both pieces are copied here in the draft format provided by the bill drafter, Lisa Mecklenberg Jackson.

LC 0158 Permanent Public Access – The purpose of this legislation is to revise the 1947 statues regarding state publications to ensure that permanent public access to all state government published information in whatever format (paper or electronic) is maintained.

LC 0157 Information Access Program – MCA 22-1-325 to 22-1-331, the Information Access Montana Act was written in 1989. This proposed revision seeks to broaden these statues to better allow the State Library Commission to put into practice the original intent of this legislation, that is, to encourage Montana libraries to share resources one with another and to get more library materials into Montanans' hands, quicker, more conveniently, and at a cost libraries can afford. Two sections, 22-1-328. "State interlibrary loan program", and 22-1-329 "State multilibrary card" are the primary focus of the Commission's requested changes.

A third piece of legislation is showing up on the online system entitled Encourage construction of new local libraries, LC0194 and the requester is Sam Kitzenberg. No additional details on this piece at this time.

Montana Library Association Government Affairs Committee Chairperson, Lois Fitzpatrick asked me to report the following regarding MLA and Legislation:
