What does this mean for Montana State Library and their Gale products? Do these publications get high usage?

While *Time | Forbes* publications are accessed regularly, it is important to note that they accounted for 2.11% of usage across your entire suite of Gale databases with 0.14% of this usage was in public libraries, 0.48% usage in K12 libraries and 1.49% usage in academic libraries. Also, *Time*, while a much respected publication, is not in the top ten of the most used publications in our products. It is also important to note that many of these magazines are currently being scaled back due to their declining revenues. While these publications are perceived as being popular, they account for a small fraction of the usage. The majority of their usage is from current content, which we will link out to through our products when available on the open web. It is also important to recognize that we have access to thousands of news sources that report on the same topics as *Time* and *Forbes*.

How many titles have been added to Montana's contract since 2007?

It is important to note that while you will lose full text access to these titles, Gale has added 4,712 titles and over 4 million articles since your contract began in 2007.
