Phase Eleven new libraries are the Rosebud County Library, Stillwater County Library and the West Yellowstone Public Library. This brings the consortium to 45 members. Phase Twelve begins in April and there are several libraries that have requested cost estimates. The members have added E-pubs to their collection through two separate purchases since November. The annual membership meeting is scheduled for May 5, in coordination with the Montana Shared Catalog spring meetings, in Missoula.

The two digital scanner/laptop sets are now available to libraries, archives, museums and other institutions interested in contributing digital collections to the MMP. As of February 2011 there were 135,739 items and 34 published collections. Tina Kirkham, MMP Support, is in Billings March 4 providing training to several area librarians on the basics of scanning, creating preservation and access images, the use of the statewide Digital Archive, metadata and general MMP workflow. The MMP annual membership meeting is scheduled for April 7, 3:45-4:45, during the MLA conference.

Medical Logistics Solutions has gone beyond the basic scope of the pilot by moving additional materials such as the MSL Laptop Lab and the Ready to Read trunks between requesting libraries. However, when Missoula Public and Miles City Public libraries attempted to utilize MLS carriers to move their Shared Catalog Partner items directly between their two libraries, rather than using the bus, MLS was not able to meet the level of volume with their current size of vehicles. The libraries have switched back to using the bus. The crates supplied by MLS are wearing out and will need to be replaced. In addition, reports of slow deliveries, some significant, are slowly increasing as more libraries participate. Given the end date of the Pilot (6/30/2011) and the fact that overall reception to the Pilot continues to be strong, the State Library will stay with MLS through the Pilot's conclusion.

Open URL Resolver/Integrated Discovery System:

An RFP for a statewide, shared instance of these "next generation" discovery tools was issued February 16, following an RFI (Request for Information) process that was educational in the responses received. An ad-hoc subcommittee of the Council is assisting the State Library with this work. Committee members are:

The RFP describes two phases of the resulting contract. The first 14 months will target the existing 133 Montana Shared Catalog libraries and include implementation of the statewide databases, Heritage Quest, Montana Memory Project, any local databases or resources freely available without subscription restrictions and capable of being harvested for records, WorldCat.org and the Montana Shared Catalog SirsiDynix ILS. If possible, the current Heritage Quest subscription would be included for all public libraries and MontanaLibrary2Go would be included as additional resources discoverable under these tools. The second 12 months will focus on an expansion to include any interested Montana library, additional subscriptions and resources and additional ILS where the ILS technology is capable of this type of interoperability. Responses to the RFP are due March 3. The evaluation committee meets March 30 to score the responses and make a selection.
