Re: Montana Land Information Act Grant Funding Approved Recommendations

Please find the attached report on State Fiscal Year 2020 Montana Land Information Act (MLIA) grant funding recommendations based on MAR 10.102.9105. There was a total of 16 grant applications submitted and considered for funding. The MLIAC Grant Subcommittee reviewed and scored all applications. The Subcommittee recommended to the Montana Land Information Advisory Council that 15 applications be considered for funding.

At its April 2, 2019, meeting, the Council approved the Subcommittee's prioritized list, included in the report below, for funding for grants 1-15 for a total amount of \$250,000.
