
Attached to this memo is the fourth quarter financial report for FY 2019, for your consideration.


Items to note:

- MSL reverted \$37,795 in General Fund in FY19, of which \$26,159 was Personal Services.
- Coal Severance Tax appropriation was fully funded and expended before year end.
- We are in the process of aligning each LSTA grant with one single state fiscal year. This will help significantly with tracking and budgeting for each LSTA grant. We plan to have all LSTA 19 funds expended in FY20 and begin to spend LSTA 20 in FY21.
