**Re:** FY 21 Library Development Budget

The State Library was recently informed that Coal Severance Tax (CST) revenue is projected to be 10% lower in FY 2020 and 20%, or \$95,000, lower than what was appropriated to the State Library by the Legislature. We are grateful that Montana received an increase in federal FY 2020 Library Services Technology Act funds which staff recommend using to backfill much of the loss of CST funds.

The following budget is presented for discussion as the State Library seeks advice from the Network Advisory Council about funding priorities and options.
