Re: MLIA GRANT FUNDS FY2022

The attached report outlines the prioritization of funding for the Montana Land Information Act Grant Program State Fiscal Year 2022, based on ARM 10.102.9105.

A total of nine grant applications were submitted to the Montana State Library for consideration for the FY22 MLIA Grant Program. MSL's newly implemented grant management tool, Amplifund, was successfully implemented and used for this application process. All nine applications were reviewed internally by the Montana State Library staff and submitted to the Montana Land Information Advisory Council's Grant Review Subcommittee. The Grant Review Subcommittee reviewed and ranked all applications. Eight of the nine grants met the relevance and purpose of the MLIA and were prioritized for funding. Rank, funding approval, additional recommendations, and stipulations are outlined in the attached report.

The Council approved the Subcommittee's prioritization at the April 6, 2021 meeting. We recommend the approval of the MLIA Grant FY2022 program funding and prioritization as recommended and endorsed by the Council.
