
Items to note:


• MSL has expended 73% of its annual budget as of Q4 2021.

- Most unspent appropriation is due to continuing grants and contracts.
- Several workgroups exceeded budget due to year end priorities.
- LSTA funding appears underspent due to ARPA funding, which extends to Dec 2022.
- LSTA 20 fully expended in state fiscal year 2021.
- 29% of Coal appropriation unspent due to decreased revenue.
